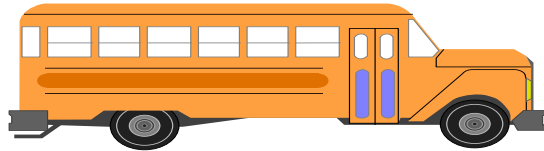

**WEST ISLIP UNION FREE SCHOOL DISTRICT  
NON-PUBLIC SCHOOL TRANSPORTATION REQUEST  
2021 – 2022 SCHOOL YEAR**

Requests for transportation to non-public schools must be filed in writing with the West Islip School District by April 1, 2021 for the 2021 - 2022 school year. To qualify for transportation, the school must not be further than 15 miles from the child's home.

Parents are advised to file even if admission to the non-public school is still in question.

An application is late if it is filed after April 1 or if filed more than 30 days after establishing residence in the West Islip Union Free School District. In this event, Part B of the application must be completed by the parent/guardian providing a "reasonable explanation for the delay" as required by Chapter 719 of the Education Law as amended. Chapter 719 requires that transportation be provided if there is "reasonable explanation" for the delayed request.

**The formal application must be submitted annually. This application must be returned by April 1, 2021 to:**
